3. SPAR ID’s are required for all players, coaches and team parents. ID’s will be checked at the start of each game. Youth Volunteer Coaches and Team Parents must clear an annual background check prior to volunteering.

A child may play UP an age division, but cannot pay down.

Age Divisions

- 12- Under - cannot be 13 before June 1, Current Year
- 14- Under - cannot be 15 before June 1, Current Year
- 16- Under - cannot be 17 before June 1, Current Year
- 18- Under - cannot be 19 before June 1, Current Year
- 18-24 - cannot be 25 before June 1, Current Year
