Parental/Guardian Permission and Waiver

By my signature below, I, the parent or guardians of the above-named participant, give my permission for him/her to participate in the Shreveport Public Assembly & Recreation (SPAR) Youth Football League. I acknowledge that I am fully aware of the potential dangers of participating in any sport and I fully understand that participating in football may result in any injuries, paralysis, permanent disability and/or death. Therefore, I do hereby, for the above-named participant, agree to indemnify, defend and hold harmless the City of Shreveport, its elected officers, employees, sponsors and agents against any and all claims, demands, suits, damages and expenses that may arise out of or in connection with the purposes stated herein. I also agree to provide a certified birth certificate of the above-name which will be kept on file at the SPAR Athletic Office.

Adult Code of Conduct

Any adult who is using alcohol, tobacco and/or appears intoxicated at a SPAR Youth Football game/event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, taunts, ridicules, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee shall be asked to leave the event premises and subject to be permanently banned from all SPAR Youth League events. Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens bodily harm shall be permanently banned from all SPAR Youth Athletic events and prosecuted to the fullest extent of the law.

I will demand a sports environment for my child that is free of drugs, tobacco, and alcohol, and will refrain from their use at all youth sports events.

I will remember that the game is for youth-not for adults.

I will do my very best to make youth sports fun for my child.

I will ask my child to treat other players, coaches, fans, and officials, with respect regardless of race, sex, creed, or ability. I promise to help my child enjoy the youth sports experience by doing whatever I can, such as being a respectable fan, assisting with coaching, or providing transportation.

I will require that my child's coach be trained in the responsibilities of being a youth sports coach and that the coach upholds the Coaches' Code of Ethics.
